Board member Notardonato asked if there had been any concerned raised by parents about children having to wear facemasks for the upcoming school year. Mr. Maguire responded that there was one parent in the community who had a meeting with a parent who he informed that the school will be complying with the Governors mandate about students and staff wearing facemasks.

Member Pissios asked about controlling mask use during lunch periods. Mrs. Borner explained that instead of the normal 2 grades having lunch at the same time we will be having one grade per 20-minute period. We will start lunch earlier and end earlier to allow the school to more socially distance the students.

Mr. Maguire also explained about Shield testing for Covid which is being offered at all schools which will be an additional mitigation strategy available to the district and will lessen the period of time that a student would need to quarantine after exposure.

Goal 1:

A. Improvement of Academic Achievement

- Update on Summer Learning Opportunities SEL learning challenge, SEL self care choice boards were giving to students
- Summer Social Emotional Learning
- Summer Reading Challenge students in Kindergarten through 5th grade were given 5 pack books, which included a work sheet for each book. 1 day each month students brought in their work sheets and got an ice cream treat. Students get to keep the books
- JumpStart Programs for Kindergarten, 1st & 2nd grades 10 students identified by teachers in each grade will attend a 2 week JumpStart Program before the first day of school from 9 11, to help them get ready for the start of school.
- o Fall Assessments Students will be taking AimsWeb in grades K-2 and MAP testing in grades 3-8 to assess where they are at the start of the school year. We will also repeat these tests in Winter and Spring.
- Resources to Support Unfinished Learning We have several teachers who will be part time to help with interventions and the MTSS multitiered support system.

Goal 2:

A. Teaching, Learning, and Working with Technology

o Online Learning Tools for 2021-2022 – Rodney has been working on getting all of our on line program usage to align with SOPPA requirements.

Goal 3:

- A. Maintain a Positive, Supportive Environment for Students and Staff
- Norwood Park Township Summer Enrichment Program was very positive.
 Union Ridge teachers participated in this. Ms. Grazioso did a Shark Tank and the students hosted a product fair which raised \$1,000 which was donated to #Molly Strong a student in the neighborhood who is battling cancer.
- o Greater Chicago Food Depository Summer Meals Program partnering with the New Hope Community Food Pantry, a cold box meal, any student under the age of 18 can get a meal. We hosted this 2 days a week. Delivery times were a little inconsistent but got better after 2 weeks or so.
- o Right at School Before and After Care Program for 2021-2022 will again be available for parents at Union Ridge School.
- New Theme for 2021-2022 will be announced to the students during the first couple of weeks of school.

 - a. COVID-19 Update Shield testing and all mitigation factors put in place along with what we learned from last year should allow us to have a successful school year
