#### Dear Property Owner:

Union Ridge Elementary School District 86 has been advised that a family living with you would like to register their child (ren) in our school. When this occurs, both the property owner who is permitting a family with school-age children to live in his/her Harwood Heights/Norridge residence, as well as the person seeking to enroll the student, must complete an Affidavit of Residency and return it to the District at the time of registration. This will assist the family in meeting the residency requirement for attendance in our schools.

Status as residents for such a family is valid as long as the student(s) and custodial parent(s) live at the property owner's residence. If the student(s) and custodial parent(s) using the Harwood Heights/Norridge address vacate or move from the residence it is incumbent upon the property owner to notify the school district immediately.

Note: The School Code of Illinois states the following:

"A person who knowingly or willfully presents to any school district any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in that district without the payment of non-resident tuition charge shall be guilty of a Class C misdemeanor."

Please note that a residency arrangement of this nature is subject to periodic home visits and review by the Residency Confirmation Officers of the school district.

A person who knowingly or willfully presents to the School District any false information regarding the residency of a student for the purpose of enabling that student to Union Ridge School District #86 is guilty of a Class C misdemeanor (105 ILCS 5/10-20.12b(f).

If the above information is falsified a hearing may be required to determine that the law was violated, Union Ridge School District #86 will notify the police, and also pursue legal action to recover the tuition charge (or portion thereof). At the present time the tuition amount is approximately \$10,285.00.

You will be required to provide 4 proofs of residency which can include utility bills, mortgage information, real estate tax bill, car insurance, credit card statements, proof of village vehicle sticker purchase and driver's license. An affidavit of residency must be completed if you're living with another family/person in the district. The family/person must provide the above proof of residency in addition to your own proofs.
